



Security & Visa Application Kiosk

Overview

As security tightens in public sectors, many companies are also tightening security while maintaining efficiency and cost savings through the implementation of kiosks. For secure visitor check-in, access to confidential information via self-service, or immigration functions, kiosks act as mini patrol units for a variety of applications. Security also spans transaction kiosks by adding additional features such as security alarms, fingerprint and eye scanners, security mats and privacy screens as well as a host of biometric devices.

For example, Security KIOSKS deployed by the Security Departments enable Developed Countries to identify visitors coming in and going out the country with simplicity and speed of throughput. Such programs deploy KIOSK products configured with fingerprint capture, video picture and automated passport processing to help protect the Country's borders.

A lot of time is wasted by Foreign Embassies and Missions to disseminate information to visitors at their Embassies. Using KIOSK products visitors and Visa applicants can access information at their fingertips and even apply for Visas right from the Kiosks. These Kiosks can be fitted with devices to accept application fee, scan fingerprints and passports on the spot. The applications will be screened on the spot to avoid errors or missing information and can be prescreened before being forward to the inbox of a Visa processing officer. Visitors can return to the Kiosks to check on the fate of their Visa applications.

These Kiosks can be located outside the main visitor halls of Embassies and missions to avoid crowding and to reduce excessive security checks.
